TERMS AND CONDITIONS

1. The Scope of Work is enclosed as **Annexure-I**. Bidders are required to go through the Scope of Work carefully before submission of bids.
2. The bidder should not have been debarred or blacklisted by any Central / State Government. A self-attested certification to that effect must be uploaded with the technical bid in the prescribed format. The proforma of the certificate is enclosed with the tender as **Annexure-A**.
3. All the bids must be valid for a period of 180 days from the last date of submission. In, exceptional circumstances, prior to expiry of the original time limit, the Institute may request the bidders to extend the period of validity for a specified additional period beyond the original validity of 180 days. The request and the bidders' responses shall be made in writing. The bidders, not agreeing to such extensions, will be allowed to withdraw their bids without forfeiture of their Bid Security.
4. **EMD Exemption:** EMD exemption shall be given to those bidders who are registered with the Central Purchase Organization, NSIC, or MICRO and Small Enterprises (MSEs) as defined in the MSME Procurement Policy issued by the Department of Micro and Small Enterprises (MSME). To claim the exemption, the bidder must be offering goods manufactured by themselves or providing relevant services. Exemption will not be granted in case the bidder is acting as an agent for some other vendor.
5. **Instructions to the bidder of countries that share a land border with India (Rule 144(xi) GFRs).**
Any bidder from a country that shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Department for Promotion of Industry and Internal Trade (DPIIT). As per Office Memorandum No. F.7/10/2021-PPD (1) dated: 23.02.2023 issued by the Department of Expenditure (Ministry of Finance), Govt. of India, the bidder is required to submit an undertaking as per **Annexure-C**
6. **MII & Purchase Preference:**
The MII compliances and purchase preference shall be as per Govt. of India guidelines. All the bidders must upload undertaking as per **Annexure-B** with the Technical Bid.



7. Submission of Bids:

Technical bid - First sealed envelope: Should contain the technical bid consisting of all eligibility documents, all annexures (Annexure-A to Annexure E), PAN, GST, supportive documents related to experience criteria and EMD as asked in the tender document. All the above-mentioned documents should be submitted as Technical bid. 8. Eligibility Criteria:

(a) Bidder must have executed one similar work of minimum Rs. 3,20,000/- in Central/State Government/PSU/CFTI/Autonomous Body.

or

two similar works of minimum Rs. 2,00,000/- in Central/State Government/PSU/CFTI/Autonomous Body.

or

three similar works of minimum Rs. 1,20,000/- in Central/State Government/PSU/CFTI/Autonomous Body.

9. Evaluation Procedure:

Phase-I: Technical Evaluation

Technical evaluation will be done based on documents submitted by the bidder in the technical bid. Hence bidders are required to enclose all relevant documents along with the technical bid. Discrepancy in relevant supporting documents shall lead to the rejection of technical bids.

Phase-II: Financial Evaluation

- Financial bids of technically qualified bidders shall only be opened.
- The bid will be awarded to the L-1 bidder. In case of tie preference will be given to the bidder who have maximum experience in CFTIs.

10. Liquidated damages (LD): If a bidder fails to deliver the services or any part thereof within the period prescribed for delivery, the Institute shall be entitled to recover as liquidated damages a sum equivalent to 1% (one per cent) per week of the purchase order. The total damages shall not exceed 5% (five per cent) of the value of the purchase order.

11. Payment terms: 100% payment shall be made through NEFT/RTGS against submission of bills in triplicate, only after satisfying the following conditions:

- Successful delivery of service by the supplier.
- Submission of Performance security.

12. Performance Security

- To ensure due performance of the service, performance security is to be furnished by the successful bidder. The performance security should be furnished within 03 days of the award of the tender.
- Performance security should be for an amount of five per cent (5%) of the value of the supply order.
