1	The Institute reserves its right to place a reasonable limit on the total number of candidates to be called for selection process. The Institute reserves the right not to fill the posts, cancel the Advt. in whole or in part without assigning any reason and its decision in this regard shall be final.
2	Age relaxation for SC and ST candidates against reserved posts shall be admissible as per Government of India norms. In the case of candidates who have been serving in the Institute or other IITs/NITs/CFTIs etc. for at least three years on regular post, the maximum age limit may be relaxed by 5 years. (No age relaxation for the employees from private organizations shall be admissible under this clause.) Age relaxations as per GoI norms shall also be admissible to the regular employees of Central/State Governments; Ex-Servicemen, Meritorious Sports Persons etc.
3	The closing date for submission of application shall be considered the cut-off date for age, educational qualification and experience etc.
